- Stallions unable to attend may still participate and receive the same promotion
- 24-hour security provided for the entire event

ACCEPTANCE

The deadline for entry is October 25, unless stalls reach maximum capacity prior to that time.

STALLING

For stall assignment purposes, all stallions will be grouped by breeding facility. Each stallion will be provided with a heavily bedded, 10' x 10' stall and a stall card displaying a duplicate of the Stallion Reference page (extended pedigree). Every breeding facility with one to four stallions will receive one hospitality stall. Every breeding facility with five or more stallions will be provided with two hospitality stalls.

New stalls will be in place and are dark blue and beige. The front panels of the hospitality stalls will be removed for easy access. Stalls may be decorated as desired, however drilling or nailing directly into the stall is prohibited. Carpet, tables, lamps, chairs, videos, etc., could be considered and promotional materials are optional but welcome.

STALLIONS ARE NOT REQUIRED TO BE ON GROUNDS. HOWEVER, HOSPITALITY AREAS MUST REMAIN OPEN & INTACT UNTIL 3:00 PM, SATURDAY, DECEMBER 10.

FOOD AND BEVERAGE

A notice regarding alcoholic beverages and caterers is included BELOW. The City of Fort Worth and Will Rogers Memorial Center have restrictions that only allow their provider to dispense beverages. Additionally, all food must be prepared by an approved caterer.

**NOTICE TO ALL SUPER STALLION WEEKEND PARTICIPANTS
REGARDING ALCOHOLIC BEVERAGES & OUTSIDE CATERERS**

The City of Fort Worth and Will Rogers Memorial Center have imposed the following restrictions on Super Stallion Saturday:

ALCOHOLIC BEVERAGES

Participants must comply with the Food And Beverage Requirements of the City of Fort Worth and Will Rogers Memorial Center. All alcoholic beverage and/or soft drink beverage services must be provided by the facility caterer, Coburns Catering. No outside caterer or individual is allowed to sell or serve any beverage and all beverage service must be provided by Coburns Catering.

SOLUTION:

Western Bloodstock will again contract beverage service with the facility caterer, Aramark, for a large full service cash bar in the stall area. Super Stallion Saturday participants may purchase drink tickets and distribute those tickets as desired.

CATERING

All catering for any food service must be done by an approved caterer. **Any caterer may apply for approval as an outside caterer if they are not already on the approved list** by calling (817) 392-8151.
